5. The judge's decision will be final and no correspondence will be considered.
6. All entrants will be notified of the competition results and winners will receive their prize following judging.
7. Displays will be judged strictly in accordance with the criteria as outlined on this entry form.
8. Entrants must take into consideration their local environment and neighbours and ensure their displays represent no danger to the general public. Consideration must be given to noise and the levels of light emitted by your display.
9. Entries close **4.30 pm Thursday, 7 December 2017. Judging will commence the week beginning Monday, 11 December 2017.** Late entries will not be accepted.
